### DIRECTIONS FOR USE

Shake can before use. Best results are obtained if the pests are contacted directly. Treat in early morning or evening when the pests are in their nest.

### APPLICATION

Wind should always be at back of user and blowing toward the object being treated. For optimum performance, if treating overhead, align actuator spout with mark on valve up. If treating down, align actuator spout to be directly opposite mark on valve cup. Hold container in an upright position to treat. Stand a safe distance, about 2 metres, from the nest and not directly underneath. Use sweeping motion to saturate nests.
