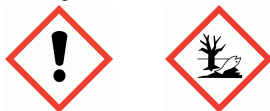

#### Description of first aid measures

<b>General information</b>	If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131126; New Zealand 0800 764 766), and follow the advice given. Show this Safety Data Sheet to a doctor.

### SECTION 5: Firefighting measures

#### Extinguishing media

**Suitable extinguishing media** The product is not flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

#### Special hazards arising from the substance or mixture

#### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Avoid discharge to the aquatic environment. Control run-off water by containing and keeping it out of sewers and watercourses. If risk of water pollution occurs, notify appropriate authorities.

**Special protective equipment for firefighters** Wear positive-pressure self-contained breathing apparatus (SCBA) and appropriate protective clothing. #### Waste treatment methods

##### **General information**

The generation of waste should be minimised or avoided wherever possible. This material and its container must be disposed of in a safe way. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.
