## MATERIAL SAFETY DATA SHEET

**1 Agrisense Cockroach Attractant Tablet**

Part No: GP2

**2 COMPOSITION**

The attractant tablet, including the food attractant, is composed of permitted food ingredients plus a trace quantity of the bitter-tasting ingestion deterrent, Bitrex™. The tablets are normally contained in blister packs.

**3 HAZARD IDENTIFICATION**

Prolonged contact with the tablet dust may cause irritation to skin, eyes and the respiratory system.

**4 FIRST AID**
**CONTACT WITH SKIN:**

Prolonged contact with the tablets may cause irritation. Wash hands thoroughly after handling. If irritation occurs seek medical advice.

**CONTACT WITH EYES:**

Rinse eyes with copious amounts of water. If irritation occurs seek medical advice.

**INGESTION:**

Rinse mouth with water. Do not induce vomiting. Due to the ingestion deterrent a bitter taste will persist for a while – although unpleasant this is harmless and will wear off with time. If feeling unwell seek medical advice

**INHALATION:**

If adverse effects are felt, remove patient to fresh air. If symptoms persist seek medical advice.

**5 FIRE FIGHTING MEASURES**

In case of fire, use water, foam, CO<sub>2</sub> or dry powder. Wear self-contained breathing apparatus and protective clothing.

**6 ACCIDENTAL RELEASE MEASURES**

In case of spillage, collect tablets, seal in a suitable container and remove.

**7.1 HANDLING**

Do not open packaging until time of use. Do not eat, drink or smoke when handling the product. Wash hands thoroughly after handling.

**7.2 STORAGE**

Store in cool dry conditions.

**8.1 PERSONAL PROTECTION**

As the product is composed of non-toxic components the necessary personal protection procedures are limited to normal personal and industrial hygiene practices.

**8.2 EXPOSURE LIMITS**

The product is composed of non-toxic permitted food ingredients and no exposure limits are defined.
