4 – FIRST-AID MEASURES

Description of first aid measures

General information: Immediately remove any clothing soiled by the product.

After swallowing:

5 – FIRE FIGHTING MEASURES

Extinguishing media

Suitable extinguishing agents: CO₂, powder or water spray. Fight larger fires with water spray or alcohol resistant foam.

Pyriproxyfen is a pyridine-based pesticide which is found to be effective against a variety of arthropods. No unacceptable risks to bystanders has been identified with proposed uses and no unacceptable risks to operators or other workers has been identified for proposed uses. At high concentrations it has possible liver toxicity and blood toxicity effects.

12 – ECOLOGICAL INFORMATION

Pyriproxyfen has low water solubility and does not readily adsorb onto soil surfaces. Measured residue concentrations have been reported to decline by 50% in 24 hours in treated ponds. Pyriproxyfen adsorbs onto suspended organic matter and remains biologically active for up to two months after an initial application. Its persistence in water in the absence of organic matter declines with increasing temperature and sunlight exposure. Pyriproxyfen is practically non-toxic to bees.
